

Other Matters

We did not audit the audited annual financial statements of one subsidiary included in the Statement, whose audited financial statements reflect total assets of ₹ 1577.12- lakhs as at March 31, 2024, total revenues of ₹ 491.84 lakhs and ₹ 1840.29 lakhs, total net profit after tax of ₹ 2.19 lakhs and ₹ 36.06 lakhs and total comprehensive income ₹ 2.19 lakhs and ₹ 36.06 lakhs for the quarter ended March 31, 2024 and for the year ended March 31, 2024 respectively, and net cash outflow of ₹ 8.58 lakhs for the year ended March 31, 2024, as considered in the Statement. The Statement also includes the Group's share of profit after tax of ₹ 79.91 lakhs and ₹ 359.23 lakhs for the quarter ended March 31, 2024 and for the year ended March 31, 2024, respectively, as considered in the Statement, in respect an associate whose audited annual financial statement has not been audited by us.

These financial statements have been audited by their respective independent auditors whose reports have been furnished to us by the Management of the Company and our opinion on the Statement, in so far as it relates to the amounts and disclosures included in respect of these subsidiary and associate, is based solely on the reports of such auditors and the procedures performed by us as stated in paragraph above. Our opinion on the Statement is not modified in respect of above matters with respect to our reliance on the work done and the report of the other auditors.

The Statement includes the results for the quarter ended March 31, 2024 being the balancing figure between the audited figures in respect of the full financial year and the published unaudited year to date figures up to the third quarter of the current financial year which were subject to limited review by us. Our report on the Statement is not modified in respect of this matter.
